**CONFIDENTIALITY UNVEILED**

Although coaching sessions are confidential to the extent permitted by law, the content of discussions between the coach and client is not considered “privileged communications” as defined by law and are subject to discovery by lawful legal process. Coaching sessions will take place at the coach’s office or at mutually agreed public locations.

**TERMINATION AND NO WARRANTY UNVEILED**

Either the client or the coach may terminate this agreement at any time for any reason by notice given to the other party. The coach makes no warranty or

**guarantee that the coaching or consulting given to the client will cause the client to accomplish the client's primary objectives or personal goals. Although the coach may provide the client with ideas and possible actions for the client's consideration, the client expressly agrees that the client is solely responsible for all decisions made and actions taken or not taken by the client as a result of the coaching process.**
